#### **Terms and Conditions**

#### 1. Conclusion of a contract

By completing and submitting this form, the supporter contracts various support options. The contract is deemed concluded upon the written acceptance of this offer by the SCC2023. The SCC2023 shall use the fund provided by the Sponsor exclusively for the realization of the conference as well as for logistic organization. The SCC2023 will mention the sponsor in advance notices including the event documents (invitation and program). The supporter may advertise these or similar statements in all languages and in the media based on written agreement with the SCC2023.

#### 2. Payment

Invoicing shall take place after confirmation by the SCC2023. For additional furnishings or supplementary costs the supporter will be invoiced as soon as the event has closed. Within 30 days after receipt of an invoice issued by the SCC2023, the supporter shall pay the funded amount.

#### 3. Exhibition

By signing the form, the supporter accepts the safety regulations of the SCC2023, the conference venue, the TÜV technical inspectorate and other comparable institutions. All police and other official regulations must be strictly observed at all times, including during erection and dismantling. Passageways, escape routes, emergency lighting, fire extinguishers and other fire-fighting facilities must not be blocked, concealed or covered up. The floors and walls of the premises are to be treated carefully and left in a proper condition. The exhibition booth must be of the size and shape agreed with the SCC2023. The SCC2023 must be informed of any additional requirements; extras are only permissible once approved in writing. The supporter shall be liable for all damage or injury caused by him/her. The supporter must dismantle and clear away the booth by the agreed time and return all furniture and fixtures hired. Any damage caused shall be cleaned and repaired at the expense of the supporter. Should the booth not be cleared away in time, this work shall be carried out by the SCC2023 at the expense of the supporter. The supporter shall be liable for all damage actually incurred.

#### 4. Limited Liability

The congress host and the SCC2023 may not be made liable for damage or injury except in cases of intent or gross negligence. The liability restriction does not apply to injury to life and limb or to damage or injury arising from the violation of cardinal obligations. The supporter is obligated to indemnify the SCC2023 from all claims for damages by third parties, insofar as these are due to intent and gross negligence by the supporter.

#### 5. General Provisions

Both parties declare that no other agreements or supplementary agreements going beyond this agreement have been reached. Amendments, supplements and ancillary agreements to this agreement must be made in writing to be effective. This also applies to the revocation of this clause requiring amendments to be in writing. If one or more provisions of this agreement should become invalid or in executable, the effectiveness of the rest of the agreement shall remain unaffected. In such a case the provision in question shall be replaced by one which is effective and enforceable and which comes as close as possible economically to the purpose envisaged by the original provision. This shall also apply to any loopholes discovered. The place of fulfilment is Berlin, Germany. The place of jurisdiction for any disputes arising from this contract is Berlin, Germany.

#### 6. Termination of the agreement

An ordinary termination of the agreement is excluded. Each contract partner shall be entitled to terminate the agreement for an important reason without observing a period of notice. An important reason exists if

- a) The SCC2023 event project cannot be carried out due to unforeseeable and/or inevitable events (e.g. the existence of a security/safety risk) or
- b) In the case of a change in the return services which is not reasonable for the supporter. Both contract partners agree that a postponement of the event is reasonable as a rule. This notice of termination must be made in writing.

In case of notice of termination the supporter is entitled to a return of the paid remuneration, unless the supporter is responsible for the termination. If the SCC2023 at the time of the termination notice has already provided advertising measures for the supporter, the SCC2023 may claim a percentage of the remuneration according to the relationship of the agreed upon and rendered advertising measures.

If neither of the contract partners is responsible for the termination without notice, the SCC2023 is furthermore entitled – after presenting invoices or other appropriate documents proving expenses which arose in the context of the return service (printing costs, etc.) – to deduct these expenses from the remuneration/non-cash items to be refunded, even if at the time of the termination no advertising measures had yet been implemented. The SCC2023 is obligated to return to the Supporter any non-cash items provided by the supporter only under the condition that the SCC2023 has received payment from the supporter for services the SCC2023 has already rendered.
